Important Case Laws:

1. In the case of M/s H. C. L. Infinite Limited vs. CTT (2011 NTN Vol-46 Trib-179) it is held by Hon'ble Court as under:

(B) Equity & Justice – As described in Shree Bhagwat Geeta – Explained :

श्री मद्भगवत् गीता के अध्याय 10 में जा ईश्वर की विभूतियाँ वर्णित की गई हैं जिसमें श्लोक-32 में वादों के बीच में होने वाले निर्णयों में ईश्वर की विभूति बताई गई है।

सर्गाणामादिरन्त त मध्यं चैवाहमर्जुन ।

अध्यात्मविद्या विद्यानां वादः प्रवदतामहम् (10/32)॥

इस प्रकार ईश्वर की वाणी में भी वादों के निर्णय में ईश्वरत्व निहित होना बताया गया है। इसके अतिरिक्त इसी सर्वमान्य ग्रन्थ में समता पर भी विशेष बल देते हुए गीता के दूसरे अध्याय श्लोक-48 में 'सिद्धसिद्धयोः समो भूत्वा समत्वं योग उच्यते' की व्याख्या की गई है जिसका अर्थ यह है कि समता में स्थिति होने पर योग की प्राप्ति होती है। इसी ग्रन्थ के अध्याय 18 में सभी में समान दृष्टिकोण रखने पर ईश्वर की पराभक्ति प्राप्त होने का उल्लेख है:

समः सर्वेषु नवजयु भूतेशु मद्धक्तिं लभते पराम् -54

इस क्षेत्र का अधिक विवेचन न करते हुये यही लिखा जाना पर्याप्त है कि न्यायिक प्रक्रिया एक ईश्वरीय शक्ति है। इसी के कारण न्यायिक अधिकारियों को न्यायाधीश कहा गया है क्यों कि वह न्याय व ईश्वरत्व को जोड़कर निर्णय करते हैं। इस भावना के साथ समता के सिद्धान्त के आधार पर सभी के साथ समान निर्णय करना एक अपीलिय पद का महत्वपूर्ण दाइत्व है। इस शक्ति का सदैव सदुपयोग ही किया जाना चाहिए।

**Latest Case Laws of CGST Act, 2017:**

2. Shree Balaji Transport v. Commissioner of Central Tax [2024] 159 taxmann.com 41 (Delhi) (W.P.(C) No. 15377 of 2023 CM APPL. No. 61691 of 2023 JANUARY 8, 2024) : Retrospective Cancellation was invalid for “failure to furnish returns for a continuous period of six months” merely because a taxpayer has not filed the returns for some period does not mean that the taxpayer’s registration is required to be cancelled with retrospective date also covering the period when the returns were filed and the taxpayer was compliant.
3. Mohana Blue Metal v. Asstt. Commissioner [2024] 159 taxmann.com 121 (Mad.) (W.P. No. 32728 of 2023 w.m.p. no. 32340 of 2023 DECEMBER 14, 2023) : The Court restored Registration in view of the fact that petitioner has been continuing his business operations and due to the ill health of the Managing Partner of the petitioner-Firm, who was incharge of filing the GST returns of the petitioner, the petitioner-Firm was not in a position to file GST Returns.
4. Mahuya Sinha v. Jt. Commissioner of Revenue [2024] 159 taxmann.com 140 (Cal.), (W.P. No. 32728 of 2023 w.m.p. no. 32340 of 2023 DECEMBER 14, 2023) : Cancellation of registration set aside as SCN alleged violation of Rule 21(a) and 21(b) only whereas the provisions contained in Rule 21(e) and Rule 18(2) was also invoked for cancelling the registration of the petitioner when the same was not the ground of show cause notice. The court also observed that it is the cardinal principle that the show cause notice must contain the allegation on which the authority proposes to initiate an action/proceeding so as to enable the notice to deal with such allegation effectively and in the case on hand, authorities traveled beyond the show cause notice while passing the impugned order.
5. Deepali Kapoor v. Avato Ward-63, State Goods & Services Tax [2024] 159 taxmann.com 157 (Delhi), (W.P.(C) No. 132 of 2024 CM APPL. 617 of 2024 JANUARY 29, 2024) : Retrospective Cancellation was invalid for “failure to furnish returns for a continuous period of six months” merely because a taxpayer has not filed the returns for some period does not mean that the taxpayer’s registration is required to be cancelled with retrospective date also covering the period when the returns were filed and the taxpayer was compliant.
6. S B Jewels v. Union of India [2024] 159 taxmann.com 163 (Guj.), (R / Special Civil Application No. 5839 of 2023 December 6, 2023) : Order cancelling the registration was set aside as show cause notice, which was issued upon the petitioners dated 8th April 2022, directed them to remain present on the very same date i.e. on 8th April 2022 for the purpose of explaining the show cause notice and petitioners were not given any material evidence which was sought to be relied upon in support of the show cause notice.
7. Dharmadutt Brick Field v. State of U.P. [2024] 159 taxmann.com 202 (All.), (WRIT TAX NO. 19 OF 2024 FEBRUARY 2, 2024) : The Court relying upon its decision quashed the order and held that impugned order does not assign any reason whatsoever for cancelling registration of the petitioner and is passed only on the ground that reply to the show cause notice is not given. The non-submission of reply to the show cause cannot be a ground for cancellation of the registration.
8. Sreenidhi Alloy Metal Suppliers v. Superintendent (GST) [2024] 159 taxmann.com 234 (Mad.) (W.P.No.24883 of 2023 WMP Nos. 24307 & 24308 of 2023 JANUARY 29, 2024) : Impugned order was quashed and remanded back as the registration was obtained in the year 2019 and no material was placed on record to support the inference that the registration was obtained in early 2019 by means of fraud, wilful misstatement or suppression of facts.
9. V. Sasikumar v. GST Superintendent [2024] 159 taxmann.com 438 (Mad.) (W.P.No.451 of 2024 W.M.P. nos. 477, 479 of 2024 JANUARY 11, 2024): The court ordered that the order cancelling the registration was issued mechanically as is evident from the reference to a reply in the first line followed by the statement in the second line that no reply was given. Therefore, since such impugned order has resulted in great prejudice to the petitioner without the petitioner being provided a reasonable opportunity to respond, the impugned order calls for interference.
10. Khandelwal Brothers v. State of U.P [2024] 159 taxmann.com 544 (All.) (WRIT TAX No. 1259 of 2023 FEBRUARY 8, 2024) : Order for Cancellation of registration was passed and petitioner stated that the order was passed without any application mind and in mechanical manner as in the first line, the order states that a reply was filed by the petitioner whereas the second line contradicts the above statement saying that no reply was filed by the petitioner. The court set aside the order taking into consideration that the original order being non-reasoned.



11. Ansal Hi-Tech Town Ships Limited v. State of UP [2024] 159 taxmann.com 575 (All.) (WRIT TAX No. 153 of 2024 FEBRUARY 15, 2024) : Order for Cancellation of registration was passed and petitioner stated that the order was passed without any application mind and in mechanical manner as in the first line, the order states that a reply was filed by the petitioner whereas the second line contradicts the above statement saying that no reply was filed by the petitioner. The court set aside the order taking into consideration that the original order being non-reasoned.
12. Sachin Kaushal v. State of U.P. [2024] 159 taxmann.com 658 (All.) (WRIT TAX No. - 1275 of 2023 FEBRUARY 13, 2024) : Order for Cancellation of registration was passed and petitioner stated that the order was passed without any application mind and in mechanical manner as in the first line, the order states that a reply was filed by the petitioner whereas the second line contradicts the above statement saying that no reply was filed by the petitioner. The court set aside the order taking into consideration that the original order being non-reasoned.
13. Iron Style v. Additional Commissioner (Appeals) [2024] 159 taxmann.com 687 (All.) (WRIT TAX No. 1493 of 2023 FEBRUARY 12, 2024) : Order for Cancellation of registration was passed and petitioner stated that the order was passed without any application mind and in mechanical manner as in the first line, the order states that a reply was filed by the petitioner whereas the second line contradicts the above statement saying that no reply was filed by the petitioner. The court set aside the order and taking into consideration that the original order being non-reasoned.
14. Mauli Sai Developers (P.) Ltd. v. Union of India [2024] 159 tamann.com 784 (Bom.) (WRIT PETITION (L) NO.38399 OF 2022 JANUARY 22, 2024) : The Court observed that vide Order dated 8th September 2022, a decision adverse to the Petitioner was passed. In these circumstances, department was bound to give a personal hearing to the Petitioner before passing the said Order dated 8th September 2022. This would be irrespective of the fact as to whether the Petitioner had asked for such a personal hearing or not. However, order has been passed without giving any personal hearing to the Petitioner, the same is in violation of the principles of natural justice and ex-facie contrary to the provisions of Section 75(4) of the CGST/MGST Act.
15. Sec 37 of CGST Act, 2017 : Railroad Logistics (India) (P.) Ltd. v. Union of India [2024] 159 taxmann.com 69 (Bom.) (WRIT PETITION (L) NO. 2429 OF 2021 JANUARY 15, 2024) : Where a genuine mistake was committed in filing of GSTR-1 by the petitioner in mentioning GSTIN of the recipient, court held that once a bona fide mistake of such nature has occurred, it needs to be rectified and more particularly, considering the observations as made by the Court, that as there is no loss of revenue, in the event such rectification is permitted to the petitioner.
16. IGST Refund of Zero Rated Supply: Tushar Kumar Chhaganlal Kothiya v. Union of India [2024] 159 taxmann.com 144 (Bom.) (WRIT PETITION NO. 1931 OF 2021 JANUARY 15, 2024) : Where petitioner is ready and willing for adjustment of the higher duty drawback as availed, balance amount being IGST Refund minus higher duty drawback be refunded to the petitioner. (Notification No. 58/2017, Dated 29-05-2017, Notification No. 131/2016, Dated 31-10-2016, Notification No. 59-2017, Dated 26-06-2017 and dated 26-07-2017).
17. Sec 73 : Cryptic Order - Inadequate Reply : Paras Enterprises v. Union of India [2024] 159 taxmann.com 657 (Delhi) (W.P.(C) No. 1983 of 2024 CMAPPLs. Nos. 8279-80 of 2024 FEBRUARY 12, 2024) : The impugned order, after recording the narration, recorded that the reply uploaded by the tax payer was not satisfactory. The order further observed that it merely stated that "no further additional reply or explanation has been received from the taxpayer despite sufficient repeated opportunities which indicate that the taxpayer has nothing to say in the matter. Hence, the order recorded that the undersigned is left with no other option to create a demand ex parte, in accordance with provisions of CGST/DGST Act." The Proper Officer opined that reply is not clear and unsatisfactory. The Court observed that in case the Proper Officer was of the view that reply is incomplete and further details were required, the same could have been sought from the petitioner, however, the record does not reflect that any such opportunity was given to the petitioner to clarify its reply or furnish further documents/details. Further petitioner was not provided with an adequate opportunity to defend the show cause notice by way of a hearing. In view of the above, the order was held not to be sustainable and the matter was liable to be remitted to the Proper Officer for re-adjudication.
